## **SPECIALTY SHOW AND SWEEPSTAKES**

American Kennel Club Rules and Regulations govern this Specialty Show.

PLEASE NOTE: Exhibitors may NOT set up crates, etc. in any part of the building prior to 6:00 AM on the day of show. No set-ups allowed Thursday afternoon. Overnight Parking for the Specialties on Thursday after 1 pm.

## **CHANGE TO BEST OF BREED**

PLEASE NOTE: Exhibitors wishing to transfer their dogs from a regular class to Best of Breed class (CD. 14, Sec. 6) must notify the Show Secretary prior to one half-hour before the start of any conformation judging at this show.

## **GENERAL RULES FOR EXHIBITORS AND SPECTATORS**

- ◆ Dogs are not allowed in Exhibitor Hall, or the Pat O'Brien Pavilion after 6:00 PM.
- ◆ No exhibitor/handler may have more crates, grooming tables or equipment than reasonable for dogs being shown. Crates must be stacked.
- ◆ No electrical cords to be run across aisles or pedestrian pathways.
- ◆ Please bring your own chairs, as chairs will not be available at ring-side.
- ◆ Crates and tables will NOT be allowed in the aisles of the show area, or within 30 feet of any ring unless marked otherwise.
- ◆ Exercise pens ARE NOT allowed in any building.
- ◆ There will be an Exhibitors area east of the Bing Crosby building. Private exercise pens may be set up in this area. NOT IN BUILDINGS. Handlers and Exhibitors may set up exercise pens in this area and may work out of their trucks or vans.
- ◆ Guards will park all handlers and will patrol throughout the show.
- ◆ NO PARKING of vehicles in fire lanes (which are 20 feet from buildings). NO crates, pens, grooming or parking of vehicles will be permitted between the buildings.
- ◆ Loading Zone will be in front of the Don Diego Clock Tower. Ten Minutes maximum to unload and move vehicle to parking area.
- ◆ Handicapped Parking is available to those with proper DMV plates. Handicapped Parking is to provide easy (paved) access, not necessarily next to rings.
- ◆ ALL EXHIBITORS will be held responsible for the cleanup after their dogs - this includes all aisles, surrounding areas and parking lots.
- ◆ PLEASE put trash in the proper receptacles.
- ◆ Your cooperation is greatly appreciated.
